

SPECIAL MEETING
BOARD OF ADJUSTMENT

OCTOBER 23, 1986

Meeting posted by notice in two public places (Town Hall Office and Post Office) on October 21, 1986.

The meeting was called to order at 7:35 P.M. by Chairman Arlene Laurenitis in the Selectmen's Room.

Members present: Ch. Arlene Laurenitis, Grayson Parker, Herbert Klein, Eddie Lamminen, Stephen Blanchard, Recording Secretary-Gail Proctor.

Ch. Laurenitis explained that the purpose of the meeting was to review the Order of Notice from the State of New Hampshire Superior Court and then decide on appropriate procedures. Copies of the Notice were distributed to the Board members. Ch. Laurenitis pointed out that on November 4th, the Board was required to file an "appearance". After that, the Board had 30 days to file a response to the Notice.

Ch. Laurenitis excused herself from the decision because she had not been an active participant in the case.

The Board voted unanimously (4-0) to proceed with the Notice. (Ch. Laurenitis pointed out that the Board had an option not to respond and "default" the Notice also).

S. Blanchard then nominated Herbert Klein to be spokesman for the Board. E. Lamminen seconded the nomination. E. Lamminen stated that although he did not want to hire a lawyer for the Board, he felt it was necessary to hire a lawyer to file the proper papers and take care of the technicalities. The other Board members agreed with Mr. Lamminen.

Herbert Klein was unanimously voted as "Special ZBA REpresentative". Mr. Klein was granted the authority to be spokeman for the Board. Herbert Klein accepted the position.

S. Blanchard said that Selectmen Greeley gave the ZBA authority to hire a lawyer and that the Town would pay for it. E. Lamminen suggested that the ZBA go to the regular Selectmen's Meeting and receive formal approval from the whole Board. Mr. Lamminen continued by stating that he would rather see the approval come from the whole Board and not just one member. Board members agreed with E. Lamminen and Ch. Laurenitis would make an appointment for Herbert Klein to appear at the next Selectmen's Meeting to request funds for the ZBA to hire a lawyer.

Ch. Laurenitis stated that she had not spoken with Mr. Levesque and she did not know if he had engaged a lawyer or not. Ch. Laurenitis commented that even if Mr. Levesque hired counsel, it would be appropriate for the ZBA to have their own representation (a lawyer).

Herbert Klein said he wanted to "check out lawyers". Mr. Klein would contact lawyers and make arrangements for the ZBA to hire one.

Ch. Laurenitis stated that she would send a certified copy of the Board's records (as requested by the Notice) to the Court with

Acting Chairman's T. Mitchell's signature.

Grayson Parker suggested that two Board members attend the Court Hearings when scheduled. The other Board members agreed.

Meeting adjourned at 8:00 P.M.
